The Services Information System User's Manual has been revised to incorporate the following changes.

Program Code 15 - <u>TANF ARRA Emergency Contingency Funds</u> is being discontinued.

A new Program Code, 16 – <u>TANF Contingency Fund</u>, is being added to the following Service Codes:

564 – <u>JobBoost</u>

Use on the DSS-5027, DSS-4263 (no Client ID required) and the DSS-1571 Part IV (Client ID required)

Note: Both current TANF workers and staff hired to provide JobBoost services may use this code on the DSS-4263.

541 – Transportation Retention Services

Use on the DSS-5027 and the DSS-1571 Part IV (Client ID required)

542 – <u>Child Care Retention Services</u> Use on the DSS-5027 and the DSS-1571 Part IV (Client ID required)

543 - Other Retention Services

Use on the DSS-5027 and the DSS-1571 Part IV (Client ID required)

A new Program Code, 23 – <u>CPS Expansion</u> is being added to the following Service Codes:

210 – CPS Assessments

Use on the DSS-5027 and the DSS-4263 (Client ID required)

215 - CPS – In-Home Services (Child Defined as Reasonable Candidate For Foster Care and Their Families)

Use on the DSS-5027 and the DSS-4263 (Client ID required)

219 - Protective Services for Children-Team Setting

Use on the DSS-5027 and the DSS-4263 (Client ID required)

Note: Although Service Code 219 may be used on the DSS-1571 Part IV with other fund sources, **CPS Expansion funds may not be used on the DSS-1571 Part IV**.

- **220 Unsuccessful Efforts to Locate Alleged Victim Child** Use only on the DSS-4263 (no Client ID required)
- 228 Preparation for and Participation In Judicial Determinations In Juvenile Court (Preplacement) Use only on the DSS-4263 (Client ID required)
- 229 Other Court Related Activity (Preplacement) Use only on the DSS-4263 (no Client ID required)
- **230 Diagnostic and Treatment Services (Non-Residential) CPS** Use on the DSS-5027 and the DSS-4263 (Client ID required)

Note: Although Service Code 230 may be used on the DSS-1571 Part IV with other fund sources, **CPS Expansion funds may not be used on the DSS-1571 Part IV**.

330 - Individual And Family Adjustment

Use on the DSS-5027 and the DSS-4263 (Client ID required)

Note: Although Service Code 330 may be used on the DSS-1571 Part IV with other fund sources, **CPS Expansion funds may not be used on the DSS-1571 Part IV**.

390 - Other Child Welfare Services

Use on the DSS-5027 and the DSS-4263 (Client ID required)

Note: Although Service Code 390 may be used on the DSS-1571 Part IV with other fund sources, **CPS Expansion funds may not be used on the DSS-1571 Part IV**.

- Note: <u>CPS Expansion</u> funds are allocated to specific counties from SSBG funds transferred from TANF. As such, these funds may only be used to provide the above services to children and their families whose income is less than 200% of Federal Poverty Level applicable to a family of the size involved.
- Special Note: Previous allocations of State funds for CPS Expansion State and CPS Expansion IV-E have been eliminated.

Program Code J – <u>Adult Protective Services State Fund</u> is being renamed to <u>Adult</u> <u>Protective Services Fund – SSBG</u>. State funds previously allocated to support the provision of Adult Protective Services are being replaced with federal funds.

Other Changes

References to the location of policy governing the use of the DSS-5027 have been updated.

The definition for Service Code 564 - <u>JobBoost</u> found in Appendix B has been edited to reflect changes in the fund source for the service.

The SIS User's Manual has been updated with these changes and is available in PDF format (see below). This version is the same as the on-line version, which is the official version of the SIS User's Manual.
