Attached to this letter are the amended Question and Answer Document, Structured Intake Report form, and Section 1407, Structured Intake. The entire Section 1407 is being sent because of varying page numbers when the document is posted on the Division's web site.

Six questions of the Question and Answer Document were previously rescinded. The Structured Intake Work Group consisting of 13 county Departments of Social Services and Division staff reviewed questions 2, 3 and 4 under Sexual Abuse Reports, question 1 under Improper Discipline Reports, and questions 1 and 3 under Abandonment Reports. These answers have now been clarified by the work group and approved by the North Carolina Association of County Directors of Social Services (NCACDSS).

The Structured Intake Report form was revised to add Moral Turpitude and Emotional Abuse to Section 21. Section 23 for Mandated Reports was added for referrals to Division of Child Development, Facility Services and Law Enforcement. Section 24 was added for signatures as all CPS referrals now require a two level review. The work group recommended these revisions and the revisions were approved by the NCACDSS.

There is a change to policy in the Sexual Abuse Screening Tool Directions regarding screening out referrals concerning children under the age of 16 having sex without the parents' knowledge or a child under the age of 16 being pregnant and there are no other allegations of abuse, neglect or dependency. On page 22 a bullet was removed that stated that a 12 year old having sex with a 15 year old without parental knowledge was a situation that would require a CPS investigative assessment for Neglect. The work group recommended bullet be deleted and the change was approved by the NCACDSS.
