- A. Part III. DSS-5104 ENTRY is revised to indicate the system assigns a form number to the DSS-5104 only after all required fields have been completed and the record updates successfully with message: THE CENTRAL REGISTRY DSS-5104 RECORD WAS SUCCESSFULLY ADDED USING THE FORM NUMBER XXXXXX.
- **B.** Part VII. DSS-5104 FORM FIELDS AND CODES of this section is revised to indicate Field 3 no longer requires the case manager's name to be keyed. The system automatically populates this field when a valid Worker ID number is keyed in Field 4.
