# I. BACKGROUND | CHANGE INTENT

The Foster Home Licensing Manual was last issued July 1, 2012 (http://info.dhhs.state.nc.us/olm/manuals/dss/csm-94/man/). Revisions have been made in several sections of the manual to use consistent language when referring to requirements for individuals 18 years of age and older. Clarifications have been made to policies related to required applicants, weekly supervision for therapeutic foster parents, exterior setting and safety, licensing visits and reporting juvenile convictions. Revisions have been made to update General Statute 131D-10.6C and information related to household members who enter the United States on a VISA. The manual replaces guidance for licensing foster homes that has been provided in memos, webinars, Supplemental Guide to Foster Home Licensing and foster home licensing training.
