## SUBJECT: NCFAST Reports in CSDW

#### I. BACKGROUND

The North Carolina Families Accessing Services through Technology (NCFAST) will be implemented beginning May 21, 2012 in scheduled pilot counties. Food and Nutrition Services (FNS) reports that are generated from the Food Stamp Information System (FSIS) are available in NCXPTR (XTND and XNET). However, with the rollout of NCFAST, conversion counties' data will not be included in these reports. Only non-converted counties' data will be included in the NCXPTR reports. Eventually when all 100 counties are in NCFAST, these reports will no longer be produced. Several reports were identified as being needed for converted counties. These reports will be stored in the Client Services Data Warehouse (CSDW).

This Admin Letter provides web links for instructions for accessing these reports, Quick Reference Guide and Training Guide documents, and a pre-recorded webinar training on CSDW and the NCFAST reports.

### II. ACCESSING THE CSDW

To access reports in CSDW, users must log in to the tool at:

http://www.csdw.dhhs.state.nc.us/.

Current CSDW users will continue using their existing login IDs. However, new users who need access must have an NCID to log into CSDW. The County Security Officer must request this access via the e-IRAAF. The individual's name, NCID, and email address must be included in the e-IRAAF request.
