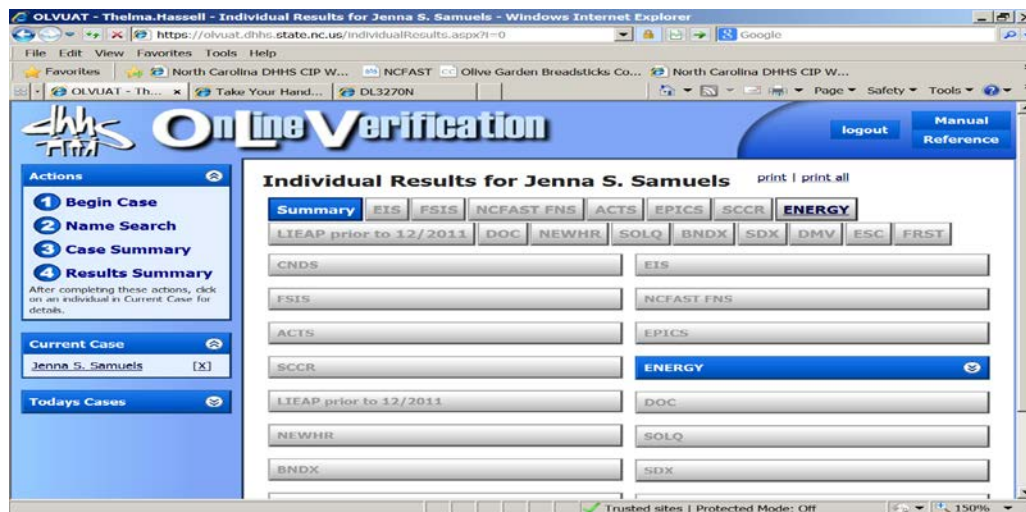

**SUBJECT:** Online Verification (OLV) Enhancements

#### I. BACKGROUND

OLV is being updated to facilitate changes to programs that have migrated into the NCFAST system. The updates include new tabs, renamed tabs and data displayed for these programs. Data from NCFAST will not display all the information that is currently displayed in the legacy systems. Outlined below are programs that have been updated in OLV.

- The CIP (Crisis Intervention Program) tab has been changed to Energy. This tab lists a summary of all cases and applications in the Energy Program Systems. It displays CIP and LIEAP (Low Income Energy Assistance Program) data. LIEAP data included in this summary is data beginning in 12/2011 (when LIEAP was incorporated into the old CIP system). LIEAP data prior to 12/2011 will be in another location, discussed later in this letter.

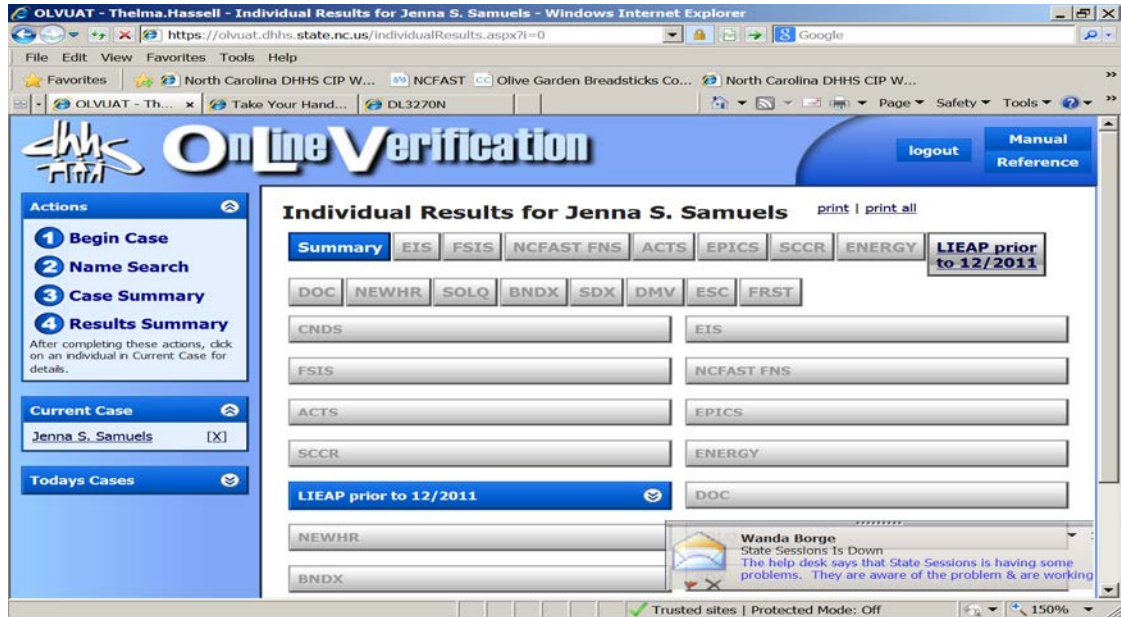


