SUBJECT: New TANF Data Collection System (TDC) Security Report

I. BACKGROUND

Security Officers are responsible for ensuring that access to State Information Systems is assessable by appropriate users. Section 3.3, Responsibilities, in the Security Manual and PM-REM-AL-06-10, dated July 15, 2010, lists systems security reports that must be reviewed at least two times per year and documented on Appendix 13. These reports include:

- 11. Low Income Energy Assistance Program (LIEAP) (old LIEAP system)
- 12. SCCRS Subsidized Child Care (GH02)
- 13. Services Information System (SIS)
- 14. SSRS Smart Start (GH02)
- 15. TANF Data Collection System (TDC)

NOTE: The Food Stamp Information System (FSIS) was retired May 31, 2013. That security report no longer needs to be reviewed. A new Historical Data Inquiry System became available July 1, 2013, to view historical FSIS data. Instructions for this system are contained in Dear County Director of Social Services Letter, PM-REM-02-2013, dated July 1, 2013. A security report for this new system will be developed and must be reviewed twice each year. Instructions for that report will be available in the near future. The monthly TANF Data Collection System (TDC) Security Report (DHRWRA TDC SECURITY RPT) has been available in NCXPTR for your review. The last run date of this report was August 31, 2012. This version, as well as the two prior versions remain in NCXPTR. This data is now available in a new report via the Client Services Data Warehouse (CSDW).

II. ACCESSING THE TDC SECURITY REPORT

The TDC Security Report for Active Users is a State Sanctioned report in the CSDW under the TANF Data Collection Folder.


